Orange County at the time of its creating embraced all of the land from the Rappahannock River, beginning at its fork, across to the Blue Ridge, down the Valley and west to include all of West Virginia and Kentucky. It was erected by Act of the General Assembly in 1734 from the upper portion of Spotsylvania County (which was created in 1720 from the northern portions of Essex, King and Queen and King William counties) and was originally coterminate with Saint Mark's Parish which had been formed three years earlier.

During the whole of the period covered by Will Book I, these bounds were not changed. There were still no settlers in the more westerly portions of this vast area, but many of the testators named herein were residents of what shortly became Augusta and Frederick counties. The Act creating these two counties was passed in 1738 but it contained a provision that no courts were to be held until there was a sufficient population. The Court of Frederick County was organized in 1743 and that of Augusta in 1745.

After 1745 Orange County included the present counties of Culpeper, Madison, Rappahannock and Greene. In 1749 the first three of these were cut off, leaving only the present territory of Orange and Greene. Orange reached its present size with the creation of Greene County in 1838.

Saint Thomas' Parish was formed from Saint Mark's in 1740. In general, its area was south of the Rapidan and the residents of the parish remained in Orange County after 1749.

Orange is fortunate in having the great majority of its records from the beginning of the county. Not only have the record books been preserved, but also there are many of the original loose papers still on file at the Court House. Mr. George H. S. King has kindly submitted a clarification of one will in this volume based upon his examination of the original which has been preserved.

W. W. Scott's A History of Orange County, Virginia (Richmond: 1907) is the only extensive volume relating to the county but much has appeared in print about its history and families.

The clerk of Orange County during the period from 1735 until July 1740 was Henry Willis. Beginning in September 1740 Jonathan Gibson signed the records as clerk.

Whenever a mark rather than a signature was affixed to a document, the mark has been placed in parenthesis. An "X" has been used to indicate not only that symbol but also a cross or any other symbol which cannot be reproduced on a typewriter.

The names have been indexed under the form considered most logical by the compiler or the one most frequently used in this volume. Cross references have been provided. The numbers of the pages upon which a person's will appears have been underlined.

I have to set in order two great house affairs both concerning the house of God as my own family. I will therefore

begin on the chiefest as the Lord's house.

The articles of agreement with my congregation and the certificate from the Governour to his Britannick Majesty of Williamsburgh testifies of whom I depend and what I and my companions after the finishing of the collections on such long and very dangerous journey for our faithful sincerity

should enjoy.

Michael Holdt hath truly accompanied us unto Danzig, but what wicked knaveries he hath raised there agt. us and what damage in our collecting affairs by the ministry in London on his return he hath caused cannot well be restituted unto these Congregation with 400 pistoles, Yea how through him and his wicked mouth that blessed institutum when a well learned man, Master George Samuel Klug by the heart bending grace of God hath fully resolved and in Elbringen as a second minister of this congregation the calling accepted and further in Danzig the confirmation received for whose maintenance in his journey from there to London we have paid 400 Elbringish 200 or Dutch Florens according to the currency in the Empire and for reason of the many recommendations from a great many high Lords both spiritual and temporal, as from other great merchants our full and abundant confidence was further confirmed, that the great God would prosper our collections so far that constantly two ministers without the least charges to the congregation could been maintained and likewise a church and other unto the worship of God becessary buildings could been erected.

Now my beloved son John Caspar Stover, minister in Conastoken, unto thee and Michael Shmidt I do give the full power to do thy earnest endeavour for the estate of this church and especially the well ordering of divine service. And if these beloved congregation should call thee for their

minister in my place thou ought to accept of it.

As soon as thou hearest anything of Michael Shmidt go to Philadelphia and assist him as good as possibly to bring unto thine house him, his and mine goods and two other families going along to Virginia. These done send directly an express messenger for the three remaining Churchwardens to come speedily to hear the general letters of attorney which thee has received, likewise the account of mine and Michael Shmits concerning the whole collection according to the memorials set down in the collection books as also in other letters not inserted into the collection books, and also especially in a small Hamburger Almanack wherein I have set down many great and small sums in the Lattine tongue.

Send also letters along to my wife and children because thee hast likewise full orders what thee shoulds't distribute for a patrimony to her self and to all my children that they

may come together with the Churchwardens.

I did send from Hamburgh unto John Henning Carstens of

London a great chest of books.

We have also got a great many more books as gifts from the booksellers in Leipzig, and Strasburg, but since they was of no service to the congregation we have changed them with a bookseller in Frankfort for 200 Frankforter handbooks which I and Michael Shmidt got bound for the congregation. The

others which we have got at Strasburg we have changed in Dearmsteddt for long books with great letters.

I and Michael Shmidt bought in Plymouth hundred pieces of

cut window glass.

Further observe as much as in thy power lyeth this congregation and her true best. Write on her behalf unto Master Fresenium the minister of Prince Darmstatts Court and desire him to send in case of necessity a new minister over here.

As touching my beloved wife it shall be given to her all what she has on cattle, horses, swines and all other living creatures, all household stuff, bedding, pewter, copper, iron, linnen, in short she shall give to no body any account in the least of these things, notwithstanding these condition when she during my absence had behaved herself as an honest woman ought to have done, that both my office and honour with her scandalous tongue, not hath blamed or slandered and therewith great offence given In such like case shall all from the greatest even unto the smallest even unto the clothes of her body be snatched away from her and shall be added to the gift bequeathed by me to the children.

But those out of the second wedlock shall receive nothing into their hands untill they have reached their respective ages. Thou my dear son shall observe them heartily for their education both in Christianity as their livelyhood from their

money which thou hast in possession.
